



Non-Residential Conservation Incentive Program

The National Fuel Conservation Incentive Program offers WNY non-residential customers several money-saving rebates for replacing specified appliances with new, energy-efficient models.

Two Ways to Save with National Fuel:

1.	Fixed (Pre-Qualified) Rebate	Available on pre-qualified equipment. (See table below.)
2.	Customized (Performance-Based) Rebate	Determined case-by-case, based on the results of an energy-use analysis. Customized rebates are determined by multiplying the annual energy savings in Mcf by \$15. This may result in a larger rebate compared with the fixed rebate.
